Peons	Candidates who have passed Middle standard examination and possess knowledge of Hindi/Punjabi.

### 2. **AGE LIMIT**:

No person shall be recruited to the service, if he/she is less than 18 years or is more than 42 years of age as on 01.01.2023. However, age relaxation for reserved posts shall be applicable as per reservation policies framed by Government of Haryana, from time to time.

## 3. **LAST DATE**:

The last date for receipt of applications shall be **08.01.2024** upto **05.00 P.M**. Applications received after due date shall not be entertained in any manner. This office shall not be responsible for any kind of postal delay.

### 4. **DATE AND PLACE OF INTERVIEW**:

Server and Peon shall mention their category in their application forms and shall

annex certificate regarding disability. The candidates of reserved category (BC-A,

BC-B & SC, as the case may be) shall also annex self attested copy of their caste

certificate alongwith their application forms.
